Procedure:

Dissolve Tromethamine in the water of phase B1; add Eusolex® 232 USC and stir until a clear solution is obtained. Then add the remaining ingredients of phase B1. Disperse phase B2 into phase B1, then add phase B3. Heat up phase A and B to 75-80°C. Add phase A into phase B while stirring. Homogenize. At 45°C, add phase C. Adjust pH value with Sodium hydroxide to 6.8-7.2.
